




The Body in Question

A chilling legal mystery that follows a juror's obsession with the case he's a part of and its devastating impact.




A Civil Action

A man risks everything to expose two corporations accused of killing children through water contamination.




Defending Jacob

A prosecutor must defend his son against accusations of murder, questioning family loyalty and justice.




The Emperor of Ocean Park

A complex tale of law, family, and betrayal, set around the mysterious death of a revered judge.




False Witness

A chilling crime novel where a defense attorney must face her past when defending a wealthy man accused of horrific crimes.




The Holdout

A judge's one-night stand leads to a dangerous conspiracy, threatening her career and her family's lives.




The Jury Master

A lawyer with a mysterious past is drawn into a high-stakes trial, uncovering secrets that could cost him everything.




The Last Chance Lawyer

A disgraced attorney takes on a final case to save a man from death row, navigating legal challenges and his troubled past.




The Legal Limit

A man's past resurfaces when his brother, convicted of a crime, seeks his help, forcing him to confront legal and moral dilemmas.




The Lincoln Lawyer

A gritty legal thriller where defense attorney Mickey Haller fights to defend a rich client accused of a high-profile crime.




Miracle Creek

A courtroom thriller examining the aftermath of a deadly explosion at a medical facility, raising questions of guilt and innocence.




Most Wanted
